- **Carcinogenic effects:** The evidence for carcinogenicity of pentachlorophenol (PCP) is based on assays that utilized less than pure PCP. Contaminants of PCP include: tri- or tetra- chlorophenol, hexachlorobenzene, polychlorinated dibenzo-p-dioxins, or polychlorinated dibenzofurans. Indications are that positive evidence for carcinogenicity is from the contaminant(s) and not the PCP. This product is or contains a component that has been reported to be possibly carcinogenic based on its IARC, ACGIH, NTP, or EPA classification. Limited evidence of carcinogenicity in animal studies. IARC: 2B - Group 2B: Possibly carcinogenic to humans (Pentachlorophenol).
