In the absence of adequate data in humans, it is reasonable, for practical purposes to regard ethynylestradiol as if it presented a carcinogenic risk to humans. Studies in humans strongly suggest that the administration of estrogens is causally related to an increased incidence of endometrial carcinoma; there is no evidence that ethynylestradiol is different from other estrogens in this respect. IARC: 2 Group 2A: Probably carcinogenic to humans (Ethynylestradiol). ACGIH: No component of this product present at levels greater than or equal to 0.1% is identified as a carcinogen or potential carcinogen by ACGIH.
