- **Carcinogenic effects:** There is sufficient evidence for the carcinogenicity of ethinylestradiol in experimental animals. In the absence of adequate data in humans, it is reasonable, for practical purposes to regard ethinylestradiol as if it presented a carcinogenic risk to humans. Studies in humans strongly suggest that the administration of estrogens is causally related to an increased incidence of endometrial carcinoma; there is no evidence that ethinylestradiol is different from other estrogens in this respect. IARC: 2 - Group 2A: Probably carcinogenic to humans (Ethinylestradiol). ACGIH: No component of this product present at levels greater than or equal to 0.1% is identified as a carcinogen or potential carcinogen by ACGIH.
