## Section 5. Firefighting measures

Flammability of the product: Flammable in the presence of an oxidizing gas (or air), a source of ignition, and when the concentration of the gas is between the lower and upper explosive limits. Keep away from heat/sparks/open flame/hot surface/oxidizing gas. No smoking. **Respiratory:** Where risk assessment shows air-purifying respirators are appropriate use a full-face respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator.
