Section 2. Hazards identifications

Physical state: Liquid

Warning: Flammable liquid and vapour. Harmful if inhaled. Causes skin irritation. Causes serious eye irritation.

Section 4. First aid measures

Flammability of the product: Flammable in the presence of a source of ignition when the temperature is above the flash point. Keep away from heat/sparks/open flame/hot surface. No smoking.

If the respirator is the sole means of protection, use a full-face supplied air respirator.
