## Section 4. First aid measures

**Eye contact:** Flush eyes with water as a precaution.

#### Section 5. Firefighting measures

**Flammability of the product:** Flammable in the presence of an oxidizing gas (e.g. air), a source of ignition, and when the concentration of the gas is between the lower and upper explosive limits. Keep away from heat/sparks/open flame/hot surface/oxidizing gas. No smoking.

If the respirator is the sole means of protection, use a full-face supplied air respirator. **Hands:** Handle with gloves. Dispose of contaminated gloves after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.
