Section 2. Hazards identifications

Physical state: Liquid

Warning: Highly flammable liquid and vapour. Harmful if swallowed. Toxic in contact with skin or if inhaled. Causes severe skin burns and eye damage.

Section 4. First aid measures

Flammability of the product: Flammable in the presence of a source of ignition when the temperature is above the flash point. Keep away from heat/sparks/open flame/hot surface. No smoking.
