Section 2. Hazards identifications

Physical state: Liquid

Warning: Flammable liquid and vapour. Toxic if swallowed or in contact with skin. Fatal if inhaled. Causes severe skin burns and eye damage.

Section 4. First aid measures

Eye contact: Rinse thoroughly with plenty of water for at least 15 minutes and consult a physician.

Section 5. Firefighting measures

Flammability of the product: Flammable in the presence of a source of ignition when the temperature is above the flash point. Keep away from heat/sparks/open flame/hot surface. No smoking.

Section 7. Handling and storage

Handling: Avoid contact with skin and eyes. Avoid inhalation of vapour or mist. Provide appropriate exhaust ventilation. Keep away from sources of ignition - No smoking.

Storage: Store at room temperature. Adequate ventilation. Protect from air. Protect from heat and ignition sources. Protect from moisture.
