## **Section 4. First aid measures**

**Eye contact:** Flush eyes with water as a precaution.

#### Section 5. Firefighting measures

Flammability of the product: Flammable in the presence of a source of ignition when the temperature is above the flash point.

If the respirator is the sole means of protection, use a full-face supplied air respirator.
