Section 2. Hazards identifications

Physical state: Liquid

Warning: Flammable liquid and vapour. Harmful if swallowed. Causes serious eye irritation.

Section 4. First aid measures

Section 5. Firefighting measures

Flammability of the product: Flammable in the presence of a source of ignition when the temperature is above the flash point.

Keep away from heat/sparks/open flame/hot surface. No smoking.

Auto-ignition temperature: 292 °C (558 °F)

Section 7. Handling and storage

Handling: Avoid contact with skin and eyes. Avoid inhalation of vapour or mist. Provide appropriate exhaust ventilation. Keep away from sources of ignition - No smoking.

Storage: Store at room temperature. Adequate ventilation. Protect from heat and ignition sources.

Section 8. Exposure Controls, Personal Protections

Respiratory: Where risk assessment shows air-purifying respirators are appropriate use a full-face respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator.
