# **Section 2. Hazards identifications**

Physical state: Liquid

Warning: Flammable liquid and vapour. Harmful if swallowed. Toxic in contact with skin. Causes severe skin burns and eye

#### Section 4. First aid measures

#### Section 5. Firefighting measures

**Flammability of the product:** Flammable in the presence of a source of ignition when the temperature is above the flash point. Keep away from heat/sparks/open flame/hot surface. No smoking.

#### Section 6. Accidental release measures

# Section 7. Handling and storage

**Handling:** Avoid contact with skin and eyes. Avoid inhalation of vapour or mist. Provide appropriate exhaust ventilation. Keep away from sources of ignition - No smoking.

Storage: Store at room temperature. Adequate ventilation. Protect from heat and ignition sources.

# Section 8. Exposure Controls, Personal Protections

**Engineering controls:** Use mechanical exhaust or laboratory fumehood to avoid exposure.

Eyes: Safety glasses with side-shields conforming to NIOSH (US) or EN 166 (EU).

**Respiratory:** Where risk assessment shows air-purifying respirators are appropriate use a full-face respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator.
