Section 2. Hazards identifications

Physical state: Liquid

Warning: Combustible liquid. Harmful if swallowed or in contact with skin. Causes severe skin burns and eye damage.

Section 4. First aid measures

Section 5. Firefighting measures

Flammability of the product: Flammable in the presence of a source of ignition when the temperature is above the flash point. Keep away from heat/sparks/open flame/hot surface. No smoking.
