# Section 2. Hazards identifications

#### Physical state: Liquid

# Section 4. First aid measures

# Section 5. Firefighting measures

**Flammability of the product:** Flammable in the presence of a source of ignition when the temperature is above the flash point. Keep away from heat/sparks/open flame/hot surface. No smoking.

**Storage:** Store at room temperature. Adequate ventilation. Protect from air. Protect from heat and ignition sources. Protect from moisture.

Engineering controls: Use mechanical exhaust or laboratory fumehood to avoid exposure.

Eyes: Safety glasses with side-shields conforming to NIOSH (US) or EN 166 (EU).

**Respiratory:** Where risk assessment shows air-purifying respirators are appropriate use a full-face respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator.
