Section 2. Hazards identifications

Physical state: Liquid

Warning: Highly flammable liquid and vapour. Causes skin irritation. Causes serious eye irritation.

Section 4. First aid measures

Eye contact: Rinse thoroughly with plenty of water for at least 15 minutes and consult a physician.

Section 5. Firefighting measures

Flammability of the product: Flammable in the presence of a source of ignition when the temperature is above the flash point. Keep away from heat/sparks/open flame/hot surface. No smoking.

Lower explosion limit: 3.4 Vol%

Upper explosion limit: 9.1 Vol%

Auto-ignition temperature: 490 °C (914 °F)

Section 6. Accidental release measures

Section 7. Handling and storage

Handling: Avoid contact with skin and eyes. Avoid inhalation of vapour or mist. Provide appropriate exhaust ventilation. Keep away from sources of ignition - No smoking.

Storage: Store at room temperature. Adequate ventilation. Protect from heat and ignition sources.

Section 8. Exposure Controls, Personal Protections

Engineering controls: Use mechanical exhaust or laboratory fumehood to avoid exposure.

Eyes: Safety glasses with side-shields conforming to NIOSH (US) or EN 166 (EU).

Respiratory: Where risk assessment shows air-purifying respirators are appropriate use a full-face respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. If the respirator is the sole means of protection, use a full-face supplied air respirator. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU).

Hands: Handle with gloves. Dispose of contaminated gloves after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.
