**Physical state:** Liquid

## **Section 4. First aid measures**

**Eye contact:** Flush eyes with water as a precaution.

## **Section 5. Firefighting measures**

**Flammability of the product:** Flammable in the presence of a source of ignition when the temperature is above the flash point. Keep away from heat/sparks/open flame/hot surface. No smoking.

If the respirator is the sole means of protection, use a full-face supplied air respirator. **Hands:** Handle with gloves. Dispose of contaminated gloves after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.
