### Section 2. Hazards identifications

**Physical state:** Liquid

### **Section 4. First aid measures**

**Eye contact:** Rinse thoroughly with plenty of water for at least 15 minutes and consult a physician.

### **Section 5. Firefighting measures**

**Flammability of the product:** Flammable in the presence of a source of ignition when the temperature is above the flash point. Keep away from heat/sparks/open flame/hot surface. No smoking.
